# This JCR Notes:

- The JCR often endorses positions related to current affairs in general meetings.
- These resolutions are not collected into easily accessible lists and are instead only found in the minutes, which makes them hard to access.
- The inaccessibility of these resolutions means that policy positions have occasionally been forgotten and tasks have gone uncompleted.

# This JCR Believes:

  website would allow the general membership to be better aware of the activities of the

# Motion to Create a Cuth's Poetry Society (3)

# This JCR Notes:

- There is not currently a society for people to meet and discuss poetry within the JCR.
- There are many people within the JCR who read and/or write poetry.

# This JCR Believes:

- There are many people in the JCR who would appreciate a space in which to discuss poetry written by published poets, or by other students.
- A poetry society would allow those who may not study or write poetry, but have an interest in it, to participate in discussion about poetry (akin to a book club).
- It would be a safe space in which to share poems to other people in the JCR.
- A poetry society would be useful to recommend new poets to those who want to broaden their reading.
- A poetry society would encourage diverse and intersectional reading habits.

- To hold an AGM for the new society to elect an executive committee within 14 days of this motion passing.

# Motion to un-Officer the Communities Committee (4)

# This JCR Notes:

- The role of Communities Officer has been vacated due to resignation twice since its creation last academic year.
- There were no candidates for the role at Meeting 1.2, thus Communities Committee currently has no representation on the JCR Executive Committee.

### This JCR Believes:

- The role of Communities Officer is not an effective way to chair, organise, and represent the interests of Communities Committee.
- That the Communities Committee would be chaired better by an existing minority rep, taking on the role in addition to their responsibilities as a minority rep and elected to the role by the committee itself.
- The interests of minority reps would be better represented on the JCR Executive
  Committee by sending a delegate from Communities Committee to represent the
  views of members of committee, with the Communities Committee having discussed
  the agenda of the Executive Committee meeting in advance in order to raise their
  concerns with the delegate.
- The minority reps should sit on the Student's Union Committee in order to ensure that a diversity of opinion is represented in Cuth's votes in SU Assembly.

# This JCR Repeals:

# This JCR Orders:

- 3.1.4 The agenda of each meeting shall be shared with the Communities Committee in advance of each meeting.
- 3.1.5 The Communities Committee shall be invited to send a delegate to each meeting.
- 3.1.5.1 The delegate shall not be considered a member of the Executive Committee for any purposes other than attending meetings of the committee.
- (8. Communities Committee)
- 5) Discuss the agenda of JCR Executive Committee meetings and advise the nominated delegate to the Executive Committee of any concerns raised by members of minority groups that need to be brought forward to other groups, including but not limited to the executive committee and SU Committee.
- 8.1.1 It shall normally be called and chaired by the Communities Chair.
- 8.1.1.1 The President of the Society should call and chair a meeting of the Communities Committee in order to elect the Communities Chair, at some point prior to the commencement of Michaelmas term.
- 8.1.1.2 Nominations for the Communities Chair shall be conducted on an ad hoc basis in the meeting itself.
- 8.1.1.3 The President of the Society shall allow candidates the opportunity to hust and take questions, prior to conducting a secret ballot.
- 8.1.2 It shall be minuted by the Vice-President.
- 8.2 Communities Chair
- 8.14.1 Elected by the membership of the Communities Committee.
- 8.14.2 Their duties shall be to:
- 1) Chair the Communities Committee.
- 8.14.3 Any member of the Communities Committee elected prior to the meeting held to elect the Communities Chair shall be eligible to run for the position.



### (13.1.4 It shall consist of:)

- 7) Students with Disabilities (SwD) Representative (Ex-Officio),
- 8) Working Class Students' Representative (Ex-Officio),
- 9) LGBT+ Representative (Ex-Officio),
- 10) Ethnic Minorities Representative (Ex-Officio), and
- 11) International Representative (Ex-Officio).

# This JCR Mandates:

- The President of the Society should endeavour to share agendas for meetings of the JCR Executive Committee with the Communities Committee well enough in advance of each meeting so as to allow the Communities Committee to discuss the agenda.
- The Chair should replace all references to the Communities Officer relating to overseers for Method III applications to instead say "Communities Chair".
- The Chair should remove all other references to the role of Communities Officer from the Standing Orders.

#### Discussion

JC Will the organisation of Freshers' Week be hampered by a lack of Minortiy Representation on the exec?

SWC Minority Rep roles are generally quite autonomous. To an extent Freshers Week is no different.

AW They could have elected a chair by Freshers Week – the motion says a Chair must be elected prior to Michaelmas term.

JG What scenarios would mean that a Rep attends an exec meeting? Do they have input?

SWC They will always be invited. They will be sent the agendas of exec meetings beforehand, and can decide who will attend (it doesn't have to be the chair, and can be multiple members)

DT Does the Chair get the Exec discount to balls?

SWC No, as they don't have the extra responsibilities, such as setting up for balls.

RM Can I propose an amendment that they all should?

SWC That would need to pass through Finance Comm, so no.

- JG I'm uncomfortable with the idea of someone *sort of* being on the exec they have all of the input, but without a lot of the undesirable jobs what's to stop (for example) Outreach Chair, from now refusing to help out with setting up for balls?
- SWC This motion is the result of many discussions with Minority Reps. The core issue is that the role of Communities Officer is flawed no one actually wants to do it, and it's not really got a lot of responsibilities as all reps are independent. Unlike Outreach chair, it's the main bit of the job that people don't want to do (Wheras outreach will do the undesirable stuff because they are keen to organise volunteering).
- JS Minority Representation on the exec is very important, and this is probably the best way to do that.
- DT I think if we are having this conversation, we also need to question if we even need a Communities Committee?
- SWC I appreciate that point. I think the committee is still important though, as it does facilitate communication with the Exec, the President, and Vice-President, and it encourages cohension and intersectionality.

- \*JG opposes amended motion\*
- JG Just reflects my previous questions. Responsibilities lacking doesn't sit right with me so I'd rather it comes to a vote. I think we could make it like the Environment Committee, where there is no direct exec representation.
- DT I'm passionate that we get ride of the Communities Officer role, whether this motion passes or not.
- \*RM, AW, & LH reflect concerns that entirely removing exec representation would be a step in the wrong direction\*
- DP Would the Communities Committee be the only committee without an elected officer in charge? I think keeping committees organised in similar ways is important to maintain their legitimacy (NB He's German).
- SWC This would be the only committee that would operate exactly like this. But it would still be chaired by someone who has been elected to a Method I position. Every committee has quirks, they have evolved that way as it works best for the JCR. Initially this committee was chaired, but that didn't work, so this is the evolution.



RM To clarify for people who won't know: minority reps used to sit under the very large welfare campaigns committee and the consensus among us was that this didn't really work for our representation - only the senior welfare officer could represent us to the exec and they have a lot to do.

# Caucus Voting Procedure Motion (5)

# This JCR Notes:

- That minority reps are elected to represent the views and priorities of their respective minority groups to the JCR and cater for the specific needs of that group; these groups, by definition, make up only a minority of the JCR and therefore a minority of votes.
- Currently any member of St Cuthbert's Society JCR, some which are not a member of a certain minority group, can vote for minority reps.

# This JCR Believes:

- In Method I elections for minority reps, the option to abstain should always be present.
- Implementing voting by caucus would raise the voices of the minority groups to higher significance, meaning that the minority reps elected would more accurately reflect the views of the minority group in question being elected.
- Overall participation of minority groups in the JCR may be improved by this, as they are more likely to feel that their voice is being heard.
- Students identifying as part of a minority group may be more inclined to interact and talk to reps, given the reps would be elected by them alone.

# This JCR Orders:

#### Positions in the JCR Order:

#### 1. Nomenclature

Caucus voting procedure - A method of voting in which members that do not identify with the minority group the position is elected to represent are recommended to abstain in the election.

8.1.6 All positions elected by Method 1 on this committee, excluding the President of the Society and Vice-President, shall be elected by caucus voting procedure.

#### **Method I Rules Order:**

- 4.2 Caucus Voting Procedure
- 4.2.1 For those positions designated as being elected through caucus voting procedure, the election should incorporate an option to abstain due to not identifying with the given minority group.
- 4.2.2 In the event that the option to abstain receives the most votes, the option to abstain should be disqualified from the election without its votes being redistributed.
- 4.2.3 The Senior Returning Officer should make reasonable attempts to ensure that voting members are aware of the caucus voting procedure and discourage members from voting in elections for representatives for minority groups with which they do not identify.
